Pursuant to 28 U.S.C. § 1295(a)(4)(A), 35 U.S.C. §§ 141, 142, and 319, and 37 C.F.R. §§ 90.2 and 90.3, Patent Owner Nektar Therapeutics ("Patent Owner") hereby provides notice that it appeals to the United States Court of Appeals for the Federal Circuit from the Final Written Decision of the Patent Trial and Appeal Board ("Board") in Case No. IPR2019-01398, entered on July 30, 2021 (Paper 64) and from all underlying findings, orders, decisions, rulings, and opinions. This appeal is timely under 35 U.S.C. § 142 and 37 C.F.R. § 90.3(a)(1).

In accordance with 37 C.F.R. § 90.2(a)(3)(ii), Patent Owner states that the issues for appeal include, but are not limited to: whether the Final Written Decision should be vacated because the timing of the Final Written Decision did not permit an opportunity for the Director to review and issue a "final determination" within the time frame required by 35 U.S.C. § 316(a)(11); and whether the Board erred in determining that claims 1-10 of U.S. Patent No. 8,273,833 are unpatentable as obvious, including whether the Board should have applied the lead compound analysis and whether the Board appropriately applied the law relating to so-called overlapping ranges; the Board's consideration and analysis of the expert testimony, prior art, and other evidence in the record; the Board's factual findings, conclusions of law, or other determinations supporting or relating to the above issues; and the constitutionality of the present proceeding.

Pursuant to 35 U.S.C. § 142 and 37 C.F.R. § 90.2(a), this Notice is being filed with the Director of the United States Patent and Trademark Office.
