PETITIONER'S NOTICE OF APPEAL

Pursuant to 37 C.F.R. § 90.2(a), Petitioner One World Technologies, Inc. (“Petitioner”) hereby gives notice that it appeals to the United States Court of Appeals for the Federal Circuit from the Patent Trial and Appeal Board’s November 3, 2021 Final Written Decision (Paper No. 55) and all underlying orders, decisions, rulings, and opinions regarding U.S. Patent No. 9,826,686 (the “’26686 Patent”).

In accordance with 37 C.F.R. § 90.2(a)(3)(ii), Petitioner states that anticipated issues on appeal include, but are not limited to:

- 1) Whether the Board erred in determining that Petitioner did not show by a preponderance of evidence that the ’26686 patent’s claims 1-7 and 11-17 are unpatentable under 35 U.S.C. § 103 in light of FR 2,768,300 A1 to Outils Wolfe Societe Anonyme (“Outils”) in view of U.S. Patent No. 4,753,062 to Roelle (“Roelle”) and U.S. Patent No. 8,098,036 to Matsunaga et al. (“Matsunaga”).
- 2) Whether the Board erred in determining that Petitioner did not show by a preponderance of evidence that the ’26686 patent’s claims 8-10 and 18-20 are unpatentable under 35 U.S.C. § 103 in light of Outils, Roelle, Matsunaga, U.S. Patent No. 5,209,051 to Langdon (“Langdon”) and WO 2013/122266 A2 to Nakano et al. (“Nakano”).

Petitioner reserves the right to challenge any finding or determination supporting or relating to the issue listed above and to challenge any other issues decided adversely to Petitioner in the Final Written Decision and/or any orders, decisions or rulings underlying the Final Written Decision.

A copy of this Notice of Appeal is being filed with the Patent Trial and Appeal Board. In addition, this Notice of Appeal and the required docketing fees are being filed with the Clerk's Office for the United States Court of Appeals for the Federal Circuit.
