Pursuant to 35 U.S.C. §§ 141(c), 142 and 319, and 37 C.F.R. §§ 90.2–3, Patent Owner, Carucel Investments L.P., hereby amends its previous Notice of Appeal filed in this matter on April 29, 2021, to expressly add the following orders subsequently entered by the Patent Trial and Appeal Board after appeal had been taken to the Federal Circuit. The February 7, 2022 Order denying the Request of Patent Owner, Carucel Investments LP for Director Review of the Final Written Decision (Paper 35); and

In accordance with 37 C.F.R. § 90.2(a)(3)(ii), Patent Owner amends its April 29, 2021, Notice of Appeal to add the following issues to its pending appeal:

- vi. the Board’s failure to have the instant decision reviewed by an appropriate Principal Officer under *United States v. Arthrex, Inc.*;
- vii. the Board’s failure to utilize proper procedures and formal rules promulgated in compliance with the Administrative Procedures Act and the Due Process Clause of the Constitution in conducting review of the final written decision by an appropriate Principal Officer; and
- viii. all other issues decided adversely to Patent Owner in any order, decision, ruling, or opinion subsequently entered after the appeal had been taken.

All previous orders and issues identified in the original April 29, 2021 notice remain at issue in this appeal.

This amendment has been sought within the time frame prescribed by the Federal Circuit's Docket Order Dated April 29, 2022.

Pursuant to 35 U.S.C. § 142 and 37 C.F.R. § 90.2(a), this Amendment is being filed with the Director of the United States Patent and Trademark Office.
