("Shenzhen Chic") appeals to the United States Court of Appeals for the Federal Circuit from the Final Written Decision of the Patent Trial and Appeal Board in Case IPR2021-01232 entered on January 9, 2023 (Paper No. 28) and from all underlying orders, decisions, rulings and opinions.
