**PATENT OWNER'S NOTICE OF APPEAL**

Pursuant to 37 C.F.R. §§ 90.2, 90.3 and 35 U.S.C. §§ 142, 143, and 319, Patent Owner Converter Manufacturing, LLC (“Patent Owner”) hereby appeals to the United States Court of Appeals for the Federal Circuit from the Final Written Decision of the Patent Trial and Appeal Board (the “Board”) entered on October 20, 2022 (Paper 75), and the February 22, 2023 Order Denying Director Review of the Board’s Final Written Decision (Paper 80) and from all underlying findings, orders, decisions, rulings, and opinions that are adverse to Patent Owner.

In accordance with 37 C.F.R. § 90.2(a)(3)(ii), Patent Owner states that the issues on appeal include, but are not limited to: the Board’s determination that claims 1-20, 22-26, and 29 of U.S. Patent No. 10,189,624 B2 are unpatentable under 35 U.S.C. §§ 102 and 103; the Board’s consideration of expert testimony, prior art, and other evidence in the record; the Board’s failure to consider expert testimony and other evidence in the record; and the Board’s factual findings, conclusions of law, and other determinations, including evidentiary determinations, supporting or related to those issues (such as any decisions on motions to exclude evidence and objections to demonstratives), as well as other issues decided adverse to Patent Owner in any orders, decisions, rulings, and opinions.

Pursuant to 37 C.F.R. § 90.2(a)(1), this Notice of Appeal is also being filed with the Director of the United States Patent and Trademark Office. Simultaneous with this submission, a copy of this Notice of Appeal is being filed with the Board.
