Patent Owner Symantec Corporation (“Symantec”) hereby gives notice, pursuant to 35 U.S.C. § 142 and 37 C.F.R. § 90.2(a), of its appeal to the United States Court of Appeals for the Federal Circuit from the Final Written Decision of the Patent Trial and Appeal Board (“the Board”), entered on July 29, 2014 (Paper 54), and from all orders, decisions, rulings, and opinions underlying the Final Written Decision.

In accordance with 37 C.F.R. § 90.2(a)(3)(ii), Symantec anticipates that the issues on appeal may include the following:


1. Whether the Board erred in determining that claims 1, 11, 12 and 22 of U.S. Patent No. 7,093,086 (the “’086 Patent”) are unpatentable under 35 U.S.C. § 102.
2. Whether the Board erred in determining that claims 11 and 22 of the ‘086 Patent are unpatentable under 35 U.S.C. § 103.
3. Whether the Board erred in denying Symantec’s motion to amend the claims of the ‘086 Patent.
4. Whether the claim constructions adopted by the Board were correct.

Symantec reserves the right to challenge any finding or determination supporting or related to the issues listed above and to challenge any other issues decided adversely to Symantec in any orders, decisions, rulings, or opinions underlying the Final Written Decision.

Copies of Symantec's Notice of Appeal are being filed simultaneously with the Director of the United States Patent and Trademark Office, the Patent Trial and Appeal Board, and the Clerk of the United States Court of Appeals for the Federal Circuit.
