("Straight Path") appeals to the United States Court of Appeals for the Federal Circuit from the October 9, 2014 Final Written Decision (Paper No. 62) in IPR2013-00246, and from all underlying orders, decisions, rulings and opinions, including the October 11, 2013 Decision on Institution of *Inter Partes* Review (Paper No. 11) and the October 9, 2014 Order denying Patent Owner's Motion to Exclude (Paper 63).

available and prior art to the '704 patent; and (6) any findings or determinations supporting or relating to the foregoing issues, as well as all other issues decided adversely to Straight Path in any order, decisions, rulings, or opinions.
