
Notice is hereby given, pursuant to 37 C.F.R. § 90.2(a), that Patent Owner Zillow, Inc. ("Zillow") hereby appeals under 35 U.S.C. §§ 141 and 142 to the United States Court of Appeals for the Federal Circuit from the Final Written Decision entered on March 27, 2014 (Paper No. 42) (the "Final Written Decision"), and from all underlying orders, decisions, rulings, and opinions, including without limitation the Decision to Institute Trial for *Inter Partes* Review entered on April 2, 2013 (Paper No. 17).

In accordance with 37 C.F.R. § 90.2(a)(3)(ii), Zillow further indicates that the issues on appeal include, but are not limited to, the Patent Trial and Appeal Board's application and use of the broadest reasonable interpretation standard, claim construction, determination of unpatentability of claims 15 and 17 of Zillow's U.S. Patent No. 7,970,674 ("the '674 Patent") under 35 U.S.C. § 102(b), determination of unpatentability of claims 2, 5-11, 13, 14, 16, 26, 28-33, 35-37, 39, and 40 of the '674 Patent under 35 U.S.C. § 103(a), and any finding or determination supporting or related to those issues, as well as all other issues decided adversely to Zillow in any orders, decisions, rulings and opinions.

Simultaneous with this submission, a copy of this Notice of Appeal is being filed with the Patent Trial and Appeal Board. In addition, three copies of this Notice of Appeal, along with the required fees, are being filed with the Clerk's Office for the United States Court of Appeals for the Federal Circuit. 
