Notice is hereby given, pursuant to 37 C.F.R. § 90.2(a), that Patent Owner Micrografx, LLC (“Micrografx”) hereby appeals to the United States Court of Appeals for the Federal Circuit from the Final Written Decision entered on June 17, 2015 (Paper 38) (the “Final Written Decision”), and from all underlying orders, decisions, rulings and opinions, including without limitation the Decision to Initiate Trial for *Inter Partes* Review entered on August 12, 2014 (Paper 11).
