Notice is hereby given, pursuant to 37 C.F.R. § 90.2(a), that Patent Owner DataTreasury Corporation (“DataTreasury”) hereby appeals to the United States Court of Appeals for the Federal Circuit from the Final Written Decision entered on July 8, 2015 (Paper 37), and from all underlying orders, decisions, rulings and opinions, including without limitation the Decision on Institution of Covered Business Method Review entered on July 10, 2014 (Paper 17).

In addition, three copies of this Notice of Appeal, along with the required docketing fees, are being filed with the Clerk’s Office for the United States Court of Appeals for the Federal Circuit.


