Notice is hereby given, pursuant to 35 U.S.C. §§ 141(c), 142, 319; 37 C.F.R. §§ 90.2(a), 90.3(a), Federal Rules of Appellate Procedure/Federal Circuit Rule 4(3)(a), that Patent Owner Magna Electronics Inc. (“Magna”) appeals from the Patent Trial and Appeal Board’s Final Written Decision entered on June 25, 2015 (Paper 36) in the above-captioned consolidated *inter partes* reviews of U.S. Patent No. 7,459,664 (“the ’664 patent”) to the United States Court of Appeals for the Federal Circuit. Magna’s appeal includes any underlying orders, decisions, rulings, and opinions as well as any issues raised during these proceedings. This notice is timely filed within 63 days of the Board’s Final Written Decision. 37 C.F.R. § 90.3(a)(1).

In accordance with 37 C.F.R. § 90.2(a)(3)(ii), Magna further indicates that the issues on appeal include, without limitation, the following: (i) the Board’s determination that claims 1, 2, 4, 13, 14, 16, 17, 20–24, 27–30, 32, 34–36, 39, 42, 43, 45, and 49–52 of the ’664 patent are unpatentable over the art of record in this proceeding; (ii) the Board’s claim constructions; (iii) the Board’s determination that it had jurisdiction to consider the petition, including the Board’s determination that the petition was not time-barred under 35 U.S.C. § 315(b); and (iv) any finding or determination supporting or related to the above-mentioned issues as well as all other issues decided adversely to Magna including in any orders, decisions, rulings, and/or opinions.

Simultaneous with this submission, Magna is filing a true and correct copy of this Notice of Appeal with the Director of the U.S. Patent and Trademark Office and electronically filing the same, along with the required docketing fees, with the Clerk of the U.S. Court of Appeals for the Federal Circuit as set forth in the accompanying Certificate of Filing.
