Notice is hereby given, pursuant to 37 C.F.R. § 90.2(a), that Patent Owner DataTreasury Corporation (“DataTreasury”) hereby appeals to the United States Court of Appeals for the Federal Circuit from the Final Written Decision entered on September 1, 2015 (Paper 22), and from all underlying orders, decisions, rulings and opinions, including without limitation the Decision on Institution of Covered Business Method Review entered on September 4, 2014 (Paper 6).

In accordance with 37 C.F.R. § 90.2(a)(3)(ii), Patent Owner DataTreasury further indicates that the issues on appeal include, but are not limited to, the Patent Trial and Appeal Board’s determination of unpatentability of claims 1, 2, 16, 18, 22, 26, 29, 36, 38–42, 46–49, 58–60, 66–69, 73, 74, 80, 82–84, 88–91, 102, 106–110, and 114–123 of DataTreasury’s U.S. Patent No. 5,910,988 (“the ’988 Patent”) under 35 U.S.C. §§ 102, the construction of the claims of the ’988 Patent, determination that the ’988 Patent is a covered business method patent and is not a technological invention, determination that it had proper jurisdiction over the ’988 Patent, and any finding or determination supporting or related to those issues, as well as all other issues decided adversely to Patent Owner DataTreasury in any orders, decisions, rulings and opinions.
