PETITIONER'S NOTICE OF CROSS-APPEAL

Pursuant to 35 U.S.C. §§ 141(c) and 319 and 37 C.F.R. § 90.2(a), Petitioner LG Chem, Ltd. hereby cross-appeals to the United States Court of Appeals for the Federal Circuit from the Patent Trial and Appeal Board's ("Board") Final Written Decision in Case No. IPR2014-00692 entered on October 5, 2015 (Paper No. 76) ("Final Written Decision"), and from all underlying orders, decisions, rulings and opinions related thereto and included therein. Patent Owner Celgard, LLC filed an initial notice of appeal on October 8, 2015. This cross-appeal is timely under 37 C.F.R. § 90.3(a) and Rule 4(a)(3) of the Federal Rules of Appellate Procedure.

In accordance with 37 C.F.R. § 90.2(a)(3)(ii), Petitioner indicates that the issues on cross-appeal include, but are not limited to, the Board's claim construction and application of "ceramic composite layer . . . adapted to at least block dendrite growth" under the broadest reasonable interpretation standard, the Board's determination of patentability of any claims, and any finding or determination supporting or related to these issues, as well as all other issues decided adversely to Petitioner in any orders, decisions, ruling and opinion underlying or supporting the Final Written Decision.

A copy of this Notice of Cross-Appeal is being filed simultaneously with the Board and the Clerk's Office for the United States Court of Appeals for the Federal Circuit.
