Notice is hereby given, pursuant to 37 C.F.R. § 90.2(a), that Patent Owner Wildcat Licensing WI, LLC (“Wildcat”) hereby appeals to the United States Court of Appeals for the Federal Circuit from the Final Written Decision entered June 22, 2015 (Paper 45) (the “Final Written Decision”), and from all underlying orders, decisions, rulings and opinions, including without limitation the Decision of Institution of *Inter Partes Review* (Paper 9).
