Notice is hereby given, pursuant to 35 U.S.C. §§ 141(c) and 319 and 37 C.F.R. § 90.2(a), that Petitioner Square, Inc. (“Square”) cross-appeals to the United States Court of Appeals for the Federal Circuit from the Final Written Decision entered on October 30, 2015 (Paper 32) (the “Final Written Decision”) in IPR2014-01165. Patent Owner Unwired Planet, LLC filed a notice of appeal on December 31, 2015. This cross-appeal is timely under 37 C.F.R. § 90.3 and Fed. R. App. P. 4(a)(3).

In accordance with 37 C.F.R. § 90.2(a)(3)(ii), Square further states that the issues on cross-appeal include, but are not limited to: (1) whether the Patent Trial and Appeal Board (“PTAB”) correctly construed the claim term “displaying the piece of content associated with the event to a user of the wireless device” and (2) whether the PTAB correctly concluded that claims 8-12, 25-29 and 35 are not anticipated by U.S. Patent No. 7,764,185 to Manz et al.
