Notice is hereby given, pursuant to 37 C.F.R. § 90.2(a) and 35 U.S.C. §§ 141-142, that Patent Owner Enova Technology Corp. ("Enova") hereby appeals to the United States Court of Appeals for the Federal Circuit from the Final Written Decision entered on December 18, 2015 (Paper 49), and from all underlying orders, decisions, rulings and opinions.

For the limited purpose of providing the Director with the information requested in 37 C.F.R. § 90.2(a)(3)(ii), Enova indicates that the issues on appeal include, but are not limited to, the following:

- The Patent Trial and Appeal Board's (the "Board") claim construction that was unreasonably broad and divorced from the claims, specification, and prosecution history of U.S. Patent 7,900,057 B2 (the "'057 patent").
- The Board's determination of unpatentability of claims 1–32 of the '057 patent.
- The Board's legal errors in undertaking the obviousness analysis, the Board's findings that conflict with the evidence of record or are not supported by substantial evidence, and other issues decided adversely to Patent Owner.
