**PETITIONER'S NOTICE OF CROSS-APPEAL**

Pursuant to 35 U.S.C. §§ 141(c) and 319 and 37 C.F.R. § 90.2(a), Petitioner, Marvell Semiconductor, Inc., hereby cross-appeals to the United States Court of Appeals for the Federal Circuit from the Patent Trial and Appeal Board's ("Board") Final Written Decision in Case No. IPR2014-00553 entered November 30, 2015 (Paper No. 57) ("Final Written Decision"), and from all underlying orders, decisions, rulings and opinions related thereto and included therein. Patent Owner, Intellectual Ventures I LLC, filed an initial notice of appeal on February 1, 2016. This cross-appeal is timely under 37 C.F.R. § 90.3(a) and Rule 4(a)(3) of the Federal Rules of Appellate Procedure.

A copy of this Notice of Cross-Appeal is being filed simultaneously with the Board and the Clerk's Office for the United States Court of Appeals for the Federal Circuit.
