In accordance with 37 C.F.R. § 90.2(a)(3)(ii), the Patent Owner indicates that the issues on appeal include the Board's determinations of unpatentability of claims 8, 11, 12, 16, and 18 of U.S. Patent No. 6,926,544, including the determination under 35 U.S.C. § 103 of obviousness over U.S. Patent No. 6,480,390 ("Matsumiya") (Ex. 1003) in view of U.S. Patent No. 6,829,672 ("Deng") (Ex. 1005) and the determination under 35 U.S.C. § 103 of obviousness over U.S. Patent No. 6,522,534 ("Wu") (Ex. 1006) in view of U.S. Design Patent No. 199,589 ("Hoogesteger") (Ex. 1008). The Patent Owner also indicates that the issues on appeal may include the Board's interpretations of claims 8, 11, 12, 16, and 18 of the '544 Patent, including by way of example and not limitation, the phrase "hinge protuberance on at least one side of the case" in claim 11 and the phrase "hinge protuberance on a front side and back side of the case" in claim 12.
