PATENT OWNER PGS GEOPHYSICAL AS'S NOTICE OF APPEAL

Notice is hereby given, pursuant to 37 C.F.R. § 90.2(a), that Patent Owner PGS Geophysical AS (“PGS”) hereby appeals to the United States Court of Appeals for the Federal Circuit from the Final Written Decision entered June 8, 2016 (Paper 42) as it relates to claims 23, 24, and 28-30 of U.S. Patent No. 6,906,981 (“the ’981 patent), and any finding or determination supporting or relating to that decision, including the Decision on Institution of *Inter Partes* Review entered June 8, 2015 (Paper 15).

In accordance with 37 C.F.R. § 90.2(a)(3)(iii), PGS further indicates that the issues on appeal include, but are not limited to, the Patent Trial and Appeal Board’s determinations that Petitioner demonstrated by a preponderance of the evidence that claims 23, 24, and 30 of the ’981 patent were anticipated by U.S. Patent No. 6,545,944 to de Kok (Ex. 1003), and that claims 23, 24, 28, and 29 of the ’981 patent would have been obvious over the combination of U.S. Patent Nos. 5,924,049 to Beasley (Ex. 1004) and 4,953,657 to Edington (Ex. 1006). PGS appeals any finding or determination supporting or relating to those issues, as well as all other issues decided adversely to PGS in any orders, decisions, rulings, and opinions.
