Pursuant to 37 C.F.R. § 90.2(a), notice is hereby given that Patent Owner Praxair Technology, Inc. (“Praxair”) appeals to the United States Court of Appeals for the Federal Circuit from the Final Written Decision entered on October 25, 2016 (Paper 28), and from all underlying orders, decisions, rulings, and opinions.

In accordance with 37 C.F.R. § 90.2(a)(3)(ii), Praxair further indicates that the issues on appeal include, but are not limited to, the following: the Patent Trial and Appeal Board (“PTAB”)’s determination that Petitioner Air Liquide Large Industries U.S. LP proved by a preponderance of the evidence that claims 1, 3, and 8 of U.S. Patent No. 7,078,011 are unpatentable.
