Notice is hereby given, pursuant to 35 U.S.C. §§ 141(c), 142, 319; 37 C.F.R. §§ 90.2(a), 90.3(a), Federal Rules of Appellate Procedure/Federal Circuit Rule 4(3)(a), that Hilti, Inc. and Snap-on Incorporated (collectively "Petitioners") appeal from the Patent Trial and Appeal Board's ("PTAB's") Final Written Decision entered on November 14, 2016 (Paper No. 91) in the above-captioned *inter partes* review of U.S. Patent No. 7,944,173 to the United States Court of Appeals for the Federal Circuit. This notice is timely filed within 63 days of the PTAB's Final Written Decision. 37 C.F.R. § 90.3(a)(l).

Petitioners' appeal includes any underlying orders, decisions, rulings, and opinions as well as any issues raised during these proceedings.
