Notice is hereby given, pursuant to 35 U.S.C. §§ 141 and 142 and 37 C.F.R. § 90.2, that Patent Owner Unwired Planet, LLC, hereby appeals to the United States Court of Appeals for the Federal Circuit from the Final Written Decision entered on March 30, 2015 (Paper 32), and from all underlying orders, decisions, rulings and opinions.

In accordance with 37 C.F.R. § 90.2(a)(3)(ii), Patent Owner further states that the issues on appeal include, but are not limited to: (1) the claim construction of claims 1-6 of U.S. Patent No. 7,024,205 B1 (“the ’205 patent”), including without limitation the construction of “network administrator,” “prioritization,” and “any subscriber preferences”; (2) the determination that claims 1-6 of the ’205 patent were shown to be unpatentable under 35 U.S.C. § 112 for failure to comply with the written-description requirement; (3) the determinations that the ’205 patent was eligible for covered business method review; and (4) any finding or determination supporting or relating to these issues, as well as all other issues decided adversely to Patent Owner in any orders, decisions, rulings and opinions.
