- The Board's holding that claims 8 and 9 are rendered obvious by Clair in view of Fenton;
- The construction of claims 1–9 and 11–14;
- Whether Patent Owner was afforded due process in this proceeding; and
- Whether the Patent Trial and Appeal Board exceeded its statutory authority.
