Notice is hereby given, pursuant to 37 C.F.R. § 90.2(a), that Petitioner Duncan Parking Technologies, Inc. hereby appeals to the United States Court of Appeals for the Federal Circuit from the Final Written Decision entered on March 27, 2017 (Paper 29) and the Decision Granting Patent Owner's Request for Rehearing and Modifying the Prior Final Written Decision 35 U.S.C. § 318(a) (Paper 37) and 37 C.F.R. § 42.71.
