Pursuant to 35 U.S.C. §§ 141, 142, and 319, and in accordance with 37 C.F.R. §§ 90.2-90.3, Patent Owner FastVDO LLC appeals to the United States Court of Appeals for the Federal Circuit from the *Final Written Decision* of the Patent Trial and Appeal Board entered on December 11, 2017 in IPR2016-01203 (Paper 39), and from all underlying findings, determinations, orders, decisions, rulings and opinions regarding the *inter partes* review of U.S. Patent No. 5,850,482 ("the '482 Patent'"), including the DECISION Instituting *Inter Partes* Review entered on December 16, 2016 (Paper 14).

For the limited purpose of providing the Director with the information requested in 37 C.F.R. § 90.2(a)(3)(ii), Patent Owner anticipates that the issues on appeal may include, but are not limited to, the following, as well as any underlying findings, determinations, orders, decisions, rulings, opinions, or other related issues:

• Whether the Patent Trial and Appeal Board's decision finding that claims 1-3, 5, 7-10, 12-14, 16, 22-25, 28, and 29 of the '482 patent are unpatentable was "arbitrary, capricious, an abuse of discretion, or otherwise not in accordance with law; ... in excess of statutory jurisdiction, authority or limitations, or ... without observance of procedure required by law; [or] unsupported by substantial evidence ... "5 U.S.C. § 706(2)(A)-(E); and

• Whether *inter partes* review, an adversarial process used by the Patent and Trademark Office (PTO) to analyze the validity of existing patents, violates the Constitution by extinguishing property rights through a non-Article III forum without a jury and without affording due process to patent owners.
