INTELLECTUAL VENTURES I LLC'S ISSUES ON APPEAL

In accordance with 37 C.F.R. § 90.2(a)(3)(ii), Intellectual Ventures' issues on appeal include at least: (i) the Board's finding that claims 1, 3, 4, 6, 8, 9, 13, 15, 16, 18, 20, and 21 of the '827 patent are unpatentable as anticipated by Carter; (ii) the Board's finding that claims 5 and 17 of the '827 patent are unpatentable as obvious over Carter and Pitzel; and (ii) any finding or determination supporting or related to the aforementioned issues as well as all other issues decided adversely to Intellectual Ventures in any order, decision, ruling, phone conference decision, and/or opinion.
