Pursuant to 35 U.S.C. §§ 141-44 and 319, and 37 C.F.R. § 90.2-90.3, notice is hereby given that Patent Owner Hera Wireless S.A., and Sisvel UK Limited, appeals to the United States Court of Appeals for the Federal Circuit from the Final Written Decision entered February 25, 2020 (Paper 42) in IPR2018-01418, and from all underlying findings, determinations, rulings, opinions, orders, and decisions regarding the *inter partes* review of U.S. Patent No. 7,962,103 (the “’103 patent”).

In accordance with 37 C.F.R. § 90.2(a)(3)(ii), Patent Owner states that the issues on appeal may include, but are not limited to, the Board’s denial of Patent Owner’s Motion to Amend to substitute claims 7 and 8 of the ’103 patent, including the Board’s determination that proposed substitute claims 7 and 8 of the ’103 patent have been shown to be unpatentable; the Board’s consideration of the expert testimony, prior art, and other evidence in the record; the Board’s factual findings, conclusions of law, or other determinations supporting or related to those issues; as well as all other issues decided adversely to Patent Owner in any orders, decisions, rulings, and opinions. The issues on appeal may also include constitutional and Appointments Clause issues implicated by the recent *Arthrex* and *Polaris* cases. *See Arthrex, Inc. v. Smith & Nephew, Inc.*, 941 F.3d 1320 (Fed. Cir. 2019); *Polaris*

Innovations Ltd. v. Kingston Tech. Co., Inc., 792 F. App'x 820 (Fed. Cir. Jan. 31, 2020).

Pursuant to 37 C.F.R. § 90.3(b), this Notice of Appeal is timely, having been duly filed within 63 days after the Final Written Decision entered February 25, 2020.

A copy of this Notice of Appeal is being filed simultaneously with the Patent Trial and Appeal Board, the Director of the U.S. Patent and Trademark Office, the Clerk's Office for the United States Court of Appeals for the Federal Circuit, and served on Petitioners.
