Notice is hereby given, pursuant to 35 U.S.C. §§ 141(c), 142, 319; and 37 C.F.R. §§ 90.2(a), 90.3(a), that MobilePay LLC (“Patent Owner”) appeals from the Patent Trial and Appeal Board’s Final Written Decision entered on July 29, 2020 (Paper No. 36) in the above-captioned covered business method review of U.S. Patent No. 9,800,706 (the “’706 Patent”) to the United States Court of Appeals for the Federal Circuit.
