Notice is hereby given, pursuant to 35 U.S.C. §§ 141 and 142 and 37 C.F.R. §§ 90.2 and 90.3, that Patent Owner Bestway (USA), Inc.. (“Bestway”) hereby appeals to the United States Court of Appeals for the Federal Circuit from the Final Written Decision entered on June 22, 2020 (Paper 34), and from all underlying orders, decisions, rulings and opinions that are adverse to Patent Owner, including, without limitation, those within the Decision Instituting *Inter Partes* Review, (Paper 7).

In accordance with 37 C.F.R. § 90.2(a)(3)(ii), Patent Owner Bestway further indicates that the issues on appeal include, but are not limited to, the Board’s determination “that Petitioner has shown by a preponderance of the evidence that claims 1–4 are not patentable based on Yuan and Metzger” and “that Petitioner has shown by a preponderance of the evidence that claims 1–4 are not patentable based on Yuan and Reed” as recited in the Final Written Decision; the Board’s claim constructions; the Board’s consideration of the expert testimony, prior art, and other evidence in the record; and the Board’s factual findings, conclusions of law, and other determinations supporting or relating to the above issues.

Simultaneous with this submission to the Director, a copy of the Notice of Appeal is being filed with the Patent Trial and Appeal Board. In addition, the requisite copies of this Notice of Appeal, along with the required fees, are being filed with the Clerk's Office for the United States Court of Appeals for the Federal Circuit.

No fees are believed to be due to the United States Patent and Trademark Office in connection with this filing, but any such fees will be promptly paid upon notification to Patent Owner Bestway.
