United States Court of Appeals for the Federal Circuit from the Final Written

decision of the Patent Trial and Appeal Board in Case No. IPR2019-01072, entered

December 3, 2020 (Paper No. 38). For the limited purpose of providing the

Director with the information specified in 37 C.F.R. § 90.2(a)(3)(ii), Petitioner

indicates that the issues on appeal may include, but are not limited to, the following:

- Whether the PTAB erred in finding that Petitioner has shown by a preponderance of the evidence that claims 12-14 of U.S. Patent No. 9,893,215 ("the '215 Patent") are unpatentable.
- Whether the PTAB erred in finding that Petitioner has shown by a preponderance of the evidence that claims 12-14 are unpatentable under 35 U.S.C. § 103 as obvious in view of U.S. Patent Application Publication No. 2004/0112426 A1 to Hagino ("Hagino");
- 3. Whether the PTAB erred in finding that Petitioner has shown by a preponderance of the evidence that claims 12-14 are unpatentable under 35 U.S.C. § 103 as obvious in view of Hagino in view of F. Duerinckx and J. Szlufcik, "Defect passivation of industrial multicrystalline solar cells based on PECVD silicon nitride," Solar Energy Materials & Solar Cells 72 (2002) 231–246 ("Duerinckx") and B. Hoex, et al. "Ultralow surface recombination of c-SI substrates passivated by plasma-assisted atomic layer deposited Al2O3," Applied Physics Letters 89, 042112 (2006) ("Hoex 2006");

4. Whether the PTAB erred in all other prior interlocutory and underlying orders, decisions, rulings, findings and opinions decided adversely to Patent Owner, including procedural orders, discovery orders, or other findings and determinations.
