COMPLAINT

Plaintiff Annuitek, LLC files this Complaint against The Western and Southern Life Insurance Company and Integrity Life Insurance Company, for infringement of United States Patent No. 5,893,071 (the "071 Patent").

PARTIES AND JURISDICTION

- 1. This is an action for patent infringement under Title 35 of the United States Code. Plaintiff is seeking injunctive relief as well as damages.
- 2. Jurisdiction is proper in this Court pursuant to 28 U.S.C. §§ 1331 (Federal Question) and 1338(a) (Patents) because this is a civil action for patent infringement arising under the United States patent statutes.
- 3. Plaintiff Annuitek, LLC ("Plaintiff" or "Annuitek") is a Texas limited liability company with its principal office located in the Eastern District of Texas, at 719 W. Front Street, Suite 211, Tyler, Texas 75702.
- 4. Upon information and belief, Defendant The Western and Southern Life Insurance Company is domiciled in Ohio and has a principal office located at 400 Broadway, Cincinnati,

Ohio 45202. This Court has personal jurisdiction over this defendant because it has committed, and continues to commit, acts of infringement in the state of Texas, has conducted business in the state of Texas, and/or has engaged in continuous and systematic activities in the state of Texas. Specifically, and without limitation, this defendant has obtained a license and authorization from the Texas Department of Insurance to sell annuities in Texas, and it currently sells annuities throughout Texas under Texas Department of Insurance License Number 91050.

- 5. Upon information and belief, Defendant Integrity Life Insurance Company is domiciled in Ohio and has a principal office located at 400 Broadway, Cincinnati, Ohio 45202. This Court has personal jurisdiction over this defendant because it has committed, and continues to commit, acts of infringement in the state of Texas, has conducted business in the state of Texas, and/or has engaged in continuous and systematic activities in the state of Texas. Specifically, and without limitation, this defendant has obtained a license and authorization from the Texas Department of Insurance to sell annuities in Texas, and it currently sells annuities throughout Texas under Texas Department of Insurance License Number 93594.
- 6. Defendants The Western and Southern Life Insurance Company and Integrity Life Insurance Company are related companies that are both part of the Western & Southern Financial Group. They are collectively referred to in this Complaint as "Defendants."
- 7. On information and belief, Defendants' computer-implemented systems and methods for the sale, establishment, processing, monitoring, maintenance and administration of annuity products, which are alleged herein to infringe, were and/or continue to be used and/or made in the Eastern District of Texas.

VENUE

8. Venue is proper in the Eastern District of Texas pursuant to 28 U.S.C. §§ 1391(c) and 1400(b) because Defendants are deemed to reside in this district. In addition, and in the alternative, Defendants have committed acts of infringement in this district.

<u>COUNT I</u> (INFRINGEMENT OF UNITED STATES PATENT NO. 5,893,071)

- 9. Plaintiff incorporates paragraphs 1 through 8 herein by reference.
- 10. This cause of action arises under the patent laws of the United States, and in particular, 35 U.S.C. §§ 271, et seq.
- 11. Plaintiff is the owner by assignment of the '071 Patent with sole rights to enforce the '071 Patent and sue infringers.
- 12. A copy of the '071 Patent, titled "Annuity Value Software," is attached hereto as Exhibit A.
- 13. The '071 Patent is valid and enforceable, and it was duly issued in full compliance with Title 35 of the United States Code.
- 14. The '071 Patent is a prominent, pioneering patent in the field of computer-implemented systems and methods for annuities. This is evidenced in part by the extent to which the '071 Patent has been forward-cited as prior art in connection with the examination of subsequently-issued U.S. patents. The '071 Patent has been forward-cited in approximately 75 subsequently-issued U.S. patents to date, including patents originally assigned to such prominent insurance and annuity companies as The Hartford (33 times), Prudential (13 times), Lincoln National (6 times), Guardian (4 times), New York Life (2 times), Alliance, Mass Mutual, and Met Life.

(Direct Infringement)

- 15. Upon information and belief, Defendants have infringed and continue to directly infringe one or more claims of the '071 Patent, including at least claims 11 and 19, by using and/or making computer-implemented systems and methods in connection with the sale, establishment, processing, monitoring, maintenance and administration of annuity products such as Defendants' MultiVantage 10, MultiVantage 4, MultiVantage 5, MultiVantage 7, New Momentum 10, SPDA Series II 7, New Momentum 5, New Momentum 6, New Momentum 7, New Momentum QIO, SPDA Series II 1, SPDA Series II 3, SPDA Series II 5, Income Source, Pinnacle Variable Annuity, Omniflex Annuity, Secure Start Annuity, and Premium Bonus Annuity products.
- 16. Defendants' actions complained of herein are causing irreparable harm and monetary damage to Plaintiff and will continue to do so unless and until Defendants are enjoined and restrained by this Court.
 - 17. Plaintiff is in compliance with 35 U.S.C. § 287.

DEMAND FOR JURY TRIAL

Plaintiff, under Rule 38 of the Federal Rules of Civil Procedure, requests a trial by jury of all issues so triable by right.

PRAYER FOR RELIEF

WHEREFORE, Plaintiff respectfully requests the Court to:

- a) Enter judgment for Plaintiff on this Complaint on all causes of action asserted herein;
- b) Enjoin Defendants, their agents, officers, servants, employees, attorneys and all persons in active concert or participation with Defendants who receive notice of the order from further infringement of United States Patent No. 5,893,071;

- c) Award Plaintiff damages resulting from Defendants' infringement in accordance with 35 U.S.C. § 284;
- d) Award Plaintiff pre-judgment and post-judgment interest and costs; and
- e) Award Plaintiff such further relief to which the Court finds Plaintiff entitled under law or equity.
