Reasons:

1.
Plaintiff was not notified of the date of the hearing by this court. it was only 4 (four)days before the hearing date the that he learned from the defendant's counceals that the hearing was to be held.
2.
My motion as "Reply of plaintiff Kálmán Györy in support of his motion to admit the complaint under Fed. R. Civ. P. 12(b)(6)" faxed and mailed on june 2, 2004 was not taken account.
3.
It was also not taken into account that I had requested the U.S.Patent and Trademark Office (USPTO) to extend the patent rights and that an affirmation of such rights would render the defendant's motion to dismiss the complaint null and void.

Neither was it taken into account that plaintiff, for reasons beyond his control, was not in a position to attend the hearing himself or to have his interests represented by another party and that plaintiff has hardly any access or no access to the necessary provisions of the law and other relevant information.
