**PLAINTIFFS' NOTICE OF INTERLOCUTORY APPEAL**

PLEASE TAKE NOTICE that Segin Systems, Inc. and Segin Software, LLC (d/b/a RynohLive) (collectively, "Plaintiffs") in the above named case, by counsel, hereby jointly appeal to the United States Court of Appeals for the Federal Circuit from the Court's Memorandum Opinion & Order entered in this action on August 8, 2014 (Dkt. 149) granting Defendants' Renewed Joint Motion to Stay.

Appellate jurisdiction arises from the statute permitting interlocutory appeals from orders pertaining to motions to stay pursuant to Section 18(b) of the Leahy-Smith America Invents Act ("AIA"). 35 U.S.C. § 321; AIA § 18(b)(2), Pub. L. No. 112-29, Sept. 16, 2011, 125 Stat. 284, 331 ("A party may take an immediate interlocutory appeal from a district court's decision under paragraph (1) [motion for stay]. The United States Court of Appeals for the Federal Circuit shall review the district court's decision to ensure consistent application of established precedent, and such review may be de novo.").
