- Memorandum Order in this action entered on August 29, 2014 (Docket No. 506), denying GeoTag, Inc.’s Motion to Dismiss Plaintiffs’ First Amended Complaint for Lack of Subject Matter Jurisdiction Pursuant to Fed. R. Civ. P. 12(b)(1);
- Memorandum Order in this action entered on June 30, 2014 (Docket No. 494);
- Order in this action entered on April 10, 2014 (Docket No. 470), granting Google Inc.’s Motion for Summary Judgment of Non-Infringement;
- Memorandum Opinion in this action entered on April 10, 2014 (Docket No. 469), and its Redacted Version entered on April 22, 2014;
- Order in this action entered on April 3, 2014, regarding the stipulation to extend time for parties to submit the Joint Proposed Pretrial Order;
- Oral Order entered in this action on February 14, 2014, directing Geotag to file a latter addressing whether or not there are any material disputed facts regarding the operation or functionality of the accused instrumentality;
