NOTICE OF APPEAL

Notice is hereby given that Plaintiff MyMedicalRecords, Inc. (“MMR” or “Plaintiff”), in the above named case, as well as in consolidated Case No. 2:13-CV-00631-ODW-SH, hereby appeals to the United States Court of Appeals for the Federal Circuit from the final judgment [Doc. 83] in Case No. 2: 13-cv-07285-ODW-SH, entered in this action on January 9, 2015, and all related orders and matters, including those from the consolidated case:

1. The December 22, 2014, order granting Defendants’ Motion for Summary Judgment and holding that the Asserted Claims of the ’883 Patent are invalid as indefinite under 35 U.S.C. § 112 (ECF No. 79);

2. The December 23, 2014, order granting Defendants’ Motion for Judgment on the Pleadings and holding that the Asserted Claims of the ’466 Patent are invalid as unpatentable under 35 U.S.C. § 101 (ECF No. 81); and

3. The underlying claim construction (ECF No. 86) in the consolidated Case No. 2:13-CV-00631-ODW-SH.
