PARTIES

- 1. Plaintiff, Tapco International Corporation, is a Michigan corporation with its principal place of business at 45657 Port Street, Plymouth, Michigan.
- 2. Plaintiff is in the business of manufacturing and selling building products and building accessories.
- 3. Upon information and belief, Plaintiff alleges that Defendant Boss Products Corporation ("Boss"), is a New York corporation with its principal place of business at 56 Ivy Way, Lancaster, New York 14086.

4. Upon information and belief, Plaintiff alleges that Boss has conducted business in this Judicial District, including at a minimum, offering for sale and selling combined wall mounts and electrical outlet boxes, also known as Boss Siding Box #1 and Boss Siding Box #2 within this District, as well as distributing and/or inducing the distribution of brochures in this District bearing the products and an identification of Boss as the manufacturer of those products.

JURISDICTION

- This action arises out of the Patent Laws of the United States, Title 35 United States
 Code.
- 6. Jurisdiction and venue with respect to the parties and the subject matter of this Complaint is conferred upon this Court under the provisions of Title 28, United States Code, Judiciary and Judicial Procedures §§ 1331, 1338, 1391 and 1400, as well as other pertinent sections and statutes.

GENERAL ALLEGATIONS

7. United States Patent No. 4,920,708 (the '708 Patent) entitled Wall Mounting Assembly (see Exhibit A) was duly and legally issued by the United States Patent and Trademark Office to Plaintiff on May 1, 1990.

PATENT INFRINGEMENT

8. Upon information and belief, Defendant Boss has manufactured, offered for sale, and sold wall mounting assembly products infringing the aforementioned patent as a product or by using a process to manufacture the product, which product and/or process infringes the aforesaid patent under 35 U.S.C. §§ 271(a), (b), and/or (c).

WHEREFORE, Plaintiff prays that:
