1 Notice is hereby given that Plaintiff Emblaze Ltd. (“Emblaze,” now named B.S.D. Crown
2 Ltd.) in the above-captioned case hereby appeals to the United States Court of Appeals for the
3 Federal Circuit (“Federal Circuit”) from the Order Granting-In-Part Motions Seeking Review Of
4 Clerk’s Taxation Of Costs [D.E. 677] entered March 20, 2015, including all interlocutory decisions
5 and orders subsidiary thereto and subsumed therein.

6 Emblaze notes that, on August 11, 2014, defendant Apple Inc. filed a Notice Of Appeal, from
7 the merits judgment in the above-captioned matter, which has been designated by the Federal Circuit
8 as Appeal Number 14-1734, and that on February 25, 2015, plaintiff Emblaze also filed a Notice Of
9 Appeal from the merits judgment, which has been designated by the Federal Circuit as Appeal
10 Number 15-1400. Those two appeals have been consolidated by the Federal Circuit into Appeal
11 Number 14-1734. Emblaze respectfully requests that the Federal Circuit likewise consolidate this
12 appeal with Appeal No. 14-1734.
