ADVANCED GROUND INFORMATION SYSTEMS, INC.'S NOTICE OF APPEAL

Pursuant to Fed. R. App. P. 3 and 28 U.S.C. §1295, notice is hereby given that plaintiff Advanced Ground Information Systems, Inc. (“AGIS”) hereby appeals to the United States Court of Appeals for the Federal Circuit from the Final Judgment entered on May 12, 2015 (DE 171) in favor of defendant Life360, Inc. (“Life360”) and against AGIS as to Counts I, II, III, and IV of AGIS’ complaint, and from all orders, decisions, rulings, findings, and conclusions made in this action that support, relate to, or led to the Final Judgment, including: (a) the Markman Order dated November 21, 2014 (DE 77) in which claims 3 and 10 of the ’728 patent and claims 5 and 9 of the ’681 patent were found to be indefinite; (b) the oral ruling during trial on March 13, 2015 in which the court granted Life360’s motion for judgment as a matter of law of no direct infringement; (c) the Order on Trial Motions dated March 13, 2015 (DE 157) denying in part AGIS’s Motion *in Limine* and granting in part Life360’s Motion *in Limine*; and (d) the Order Granting Defendant’s Motion for Judgment as a Matter of Law – Willfulness dated March 13, 2015 (DE 158).
