NOTICE OF APPEAL UNDER 28 U.S.C. § 1295**

Notice is hereby given that Defendants Parrot S.A. and Parrot, Inc., (collectively, “Defendants”) in the above-named case, appeal to the United States Court of Appeals for the Federal Circuit from the Order dated July 28, 2015 (Doc. No. 443) Re: Plaintiff’s Motion for Attorneys’ Fees and Motion for Attorneys’ Fees under Rule 37 and Report and Recommendation of the Special Master Thereon (Doc. Nos. 415, 416, and 438), from the Final Judgment and Order entered on June 12, 2015 (Doc. No. 405), and from all orders, judgments, and rulings merged therein, and all other underlying or related orders, rulings, and findings, including but not limited to:

1. Order dated July 28, 2015 (Doc. No. 443) adopting Report and Recommendation of the Special Master (Doc. No. 438);
2. Order dated July 28, 2015 (Doc. No. 443) granting Plaintiff’s Objection to the Special Master’s Report and Recommendation Re: Fees (Doc. No. 440) with respect to fees due under Rule 37 and 35 U.S.C. § 285;

3. Order dated July 28, 2015 (Doc. No. 443) overruling Defendants' Objections to the Report and Recommendation of Special Master on Attorneys' Fees and Expenses (Doc. No. 441);
4. Order dated July 28, 2015 (Doc. No. 443) granting Plaintiff's Petition for Rule 37 Attorneys' Fees and Expenses, Pursuant to this Court's Order (Doc. No. 416);
5. Order dated July 28, 2015 (Doc. No. 443) that Defendants are to pay Plaintiff's fees under Rule 37 in the amount of \$173,013.00;
6. Order dated July 28, 2015 (Doc. No. 443) granting in part Plaintiff's Petition for Attorneys' Fees and Expenses, Pursuant to this Court's Order (Doc. No. 415);
7. Order dated July 28, 2015 (Doc. No. 443) that Defendants are to pay Plaintiff's reasonable attorneys' fees and related non-taxable expenses, under 35 U.S.C. § 285, in the total amount of \$1,686,290.14, plus interest at 6%, compounded quarterly; and
8. Memorandum Order and Order dated June 12, 2015 (Doc. Nos. 403 and 404) granting Plaintiff's Motion for Fees under Rule 37 (Doc. No. 380) and granting Plaintiff's Renewed Motion for an Exceptional Case Finding (Doc. No. 383).
