PLAINTIFF GRÜNENTHAL'S NOTICE OF APPEAL TO THE UNITED STATES COURT OF APPEALS FOR THE FEDERAL CIRCUIT

Notice is hereby given that Plaintiff Grünenthal GmbH ("Grünenthal") appeals in the above-named action to the United States Court of Appeals for the Federal Circuit from the judgments and orders listed below:¹

1) the Judgment entered on August 24, 2015, in *Endo Pharmaceuticals Inc. and Grünenthal GmbH v. Teva Pharmaceuticals USA, Inc. and Barr Laboratories, Inc.*, Case No. 12cv-8060 (TPG), (D.I. 225) denying Grünenthal's requests for relief;

¹ Grünenthal notes that Plaintiffs have filed a motion pursuant to Federal Rule of Civil Procedure 60(a) to correct the Judgment entered in the above action (D.I. 226). Accordingly, the time for Grünenthal to file a Notice of Appeal from the Judgment entered in this action does not start until this Court's resolution of the pending motion at the earliest, and this Notice of Appeal becomes effective in the above action only after the motion is resolved. *See* Fed. R. App. P. 4(a)(4)(A) and Fed. R. App. P. 4(a)(4)(B)(i); *Dudley ex rel. Estate of Patton v. Penn-America Ins. Co.*, 313 F.3d 662 (2d Cir. 2001). - 4) the Opinion entered on March 17, 2015, granting Defendants' Motion for Summary Judgment with respect to U.S. Patent No. 8,114,383 in *Endo Pharmaceuticals Inc. and Grünenthal GmbH v. Teva Pharmaceuticals USA, Inc. and Barr Laboratories, Inc.*, Case No. 12-cv-8060 (TPG), (D.I. 148); and
