NOTICE OF APPEAL

Notice is hereby given that Defendant Universal Remote Control, Inc. ("URC") appeals to the United States Court of Appeals for the Federal Circuit from the "Order Setting Award Of Fees And Expenses, Including Taxable Costs To Defendant" (Docket No. 549) entered in this action on Sept. 4, 2015.

URC files this appeal out of an abundance of caution, to preserve its right to appeal the "Order on Defendant's Motion for Attorneys' Fees" (Docket No. 475), entered on Mar. 10, 2015. That order determined that part of this case was not exceptional, and thus did not merit any attorneys' fees, under 35 U.S.C. § 285. URC previously appealed that order by notice of appeal filed on Apr. 8, 2015 (Docket No. 519). This present appeal seeks only to preserve URC's right to seek review of that order's determination that a portion of the case was not exceptional, and does not challenge the amount of fees awarded for the portion that was found to be exceptional.

URC also previously appealed, by notice of appeal filed on February 26, 2015 (Dkt. No. 471), the Final Judgment (Dkt. No. 453) entered in this action on January 27, 2015, and prior opinions and orders subsumed therein including, without limitation, the Order (Dkt. No. 435) entered in this action on December 16, 2014 and the Order granting in part Plaintiff Universal Electronics, Inc.'s, Motion for Summary Judgment (Dkt. No. 223) entered in this action on March 24, 2014, including with respect to the issues of patent misuse, unclean hands, and implied license. URC also appealed from all adverse orders, decisions, and opinions of the court entered prior to or subsequent to the entry of the Final Judgment.

The present notice of appeal is in addition to the two previous notices of appeal.
