NOTICE OF CROSS APPEAL

2 Notice is hereby given that Plaintiff Universal Electronics Inc. (“UEI”)
3 hereby appeals to the United States Court of Appeals for the Federal Circuit from
4 the Order Setting Award Of Fees And Expenses, Including Taxable Costs To
5 Defendant (Docket No. 549) (“Fee Award”) entered in this action on September 4,
6 2015, and any prior opinions and orders subsumed and merged therein. UEI files
7 this appeal in response to Defendant’s notice of appeal of the same order. It is filed
8 in order to ensure and preserve UEI’s complete ability to appeal the Order granting
9 Defendant’s Motion for Attorneys’ Fees (Docket No. 475) entered on March 10,
10 2015 (“Fees Order”). UEI seeks to appeal that part of the Fees Order that found
11 this case to be exceptional, in part, under 35 U.S.C. § 285 and to warrant an award
12 of attorneys’ fees to the Defendant, as well as the amount of the award set in the
13 Fee Award.

14 UEI filed a Notice of Appeal of the Fees Order on March 11, 2015 (Docket
15 No. 492). By that prior Notice of Appeal, UEI also appealed from the Final
16 Judgment (Docket No. 453) entered in this action on January 27, 2015, and prior
17 opinions and orders subsumed and merged therein including, without limitation, the
18 Claim Construction Order (Docket No. 60) entered in this action on February 1,
19 2013. This Notice is in addition to and supplements UEI’s prior Notice of Appeal.
