# **COMPLAINT FOR PATENT INFRINGEMENT**

Plaintiff, Shipping and Transit, LLC, by and through its undersigned counsel, hereby sues Defendant, GLOBAL EXPERIENCE SPECIALISTS, INC. ("GLOBAL"), for patent infringement, and in support, alleges as follows:

# NATURE OF THE LAWSUIT

1. This is an action for patent infringement of United States Patent Numbers: 6,415,207, 6,904,359, 6,763,299, 7,400,970 arising under the patent laws of the United States, Title 35 of the United States Code.

### **JURISDICTION AND VENUE**

- 2. This Court has subject matter jurisdiction pursuant to 28 U.S.C. § 1331; 28 U.S.C. § 1338; and 35 U.S.C. § 271.
- 3. This Court has personal jurisdiction over GLOBAL pursuant to, *inter alia*, Florida's long-arm statute, § 48.193, in that GLOBAL: (a) operates, conducts, engages in, and/or carries on a business or business adventure(s) in Florida and/or has an office or agency in Florida; (b) has committed one or more tortious acts within Florida; (c) was and/or is engaged in substantial and not isolated activity within Florida; and/or (d) has purposely availed itself of

Florida's laws, services and/or other benefits and therefore should reasonably anticipate being hailed into one or more of the courts within the State of Florida.

4. Venue is proper in this Court pursuant to 28 U.S.C. § 1391 and 28 U.S.C. § 1400.

#### THE PLAINTIFF

5. Plaintiff, Shipping and Transit, LLC, is a Florida Limited Liability Company with a principal place of business located in Boynton Beach, Florida.

#### THE DEFENDANT

6. Defendant, GLOBAL, is a Nevada Corporation with a principal place of business located in Las Vegas, Nevada. Upon information and belief, GLOBAL transacts business in Florida and within this Judicial District. GLOBAL has a Registered Agent located in Plantation, Florida, and has, at a minimum, offered to provide and/or has provided to customers within this Judicial District and throughout the State of Florida services and/or products that infringe claims of the '970 patent.

#### THE PLAINTIFF'S PATENTS

- 7. Plaintiff owns all rights, titles and interests in, and/or has standing to sue for infringement of United States Patent Number 6,415,207 (the "207 patent"), entitled "System and Method for Automatically providing vehicle status information", issued July 2, 2002. A copy of the '970 patent is attached hereto as Exhibit 1.
- 8. Plaintiff owns all rights, titles and interests in, and/or has standing to sue for infringement of United States Patent Number 6,904,359 ("the '359 patent"), entitled "Notification System and Methods with User-Defineable Notifications Based Upon Occurrence of Events", issued June 7, 2005. A copy of the '359 patent is attached hereto as Exhibit 2.

- 9. The '359 patent referenced in Paragraph 8 above was the subject of an Inter Partes Reexamination at the United States Patent and Trademark Office. A Reexamination Certificate was issued on May 25, 2010 and is attached hereto as Exhibit 3.
- 10. Plaintiff owns all rights, titles and interests in, and/or has standing to sue for infringement of United States Patent Number 6,763,299 (the "299 patent"), entitled "Notification systems and methods with notification based upon prior stop locations", issued July 12, 2004. A copy of the '299 patent is attached hereto as Exhibit 4.
- 11. Plaintiff owns all rights, titles and interests in, and/or has standing to sue for infringement of United States Patent Number 7,400,970 ("the '970 patent"), entitled "System and Method for an Advance Notification System for Monitoring and Reporting Proximity of a Vehicle", issued July 15, 2008. A copy of the '970 patent is attached hereto as Exhibit 5.

# COUNT I DIRECT PATENT INFRINGEMENT

- 12. Plaintiff hereby incorporates Paragraphs 1 through 11 set forth above as if fully set forth herein.
- Pursuant to 35 U.S.C. § 271(a), GLOBAL has directly infringed claims of the '207, '359, '299, and '970 patents through, among other activities, the commercial manufacture, sale, offer for sale, and/or use of its "FREIGHT RECEIVING TRACKING" & "SMALL PACKAGE RECEIVING" ("Defendant's Systems") functions, applications, solutions, devices, programs, products, services, methods and/or systems which utilize tracking and messaging technologies that are protected within the '207, '359, '299, and '970 patents, as every claim limitation, or its equivalent, is found in these functions, applications, solutions, devices, programs, products, services, methods and/or systems.

- 14. At a minimum, the Defendant's Systems in question infringe claims 1 and 8 of the '970 patent, in as much as it allows a user to track the movement of a vehicle that allows Defendants customers real-time access to their shipments (*The system has real-time access to data*, maintaining instant accuracy of shipment information." www.applications.ges.com), and communicates a notification to a user of the vehicle's status through automated email updates (With the ability to set up automated alerts and track shipments on line...tracking has never been more convenient for show organizers and exhibitors." www.applications.ges.com).
- 15. GLOBAL'S direct infringement has injured and will continue to injure Plaintiff unless and until a monetary judgment is entered in favor of Plaintiff and/or the Court enters an injunction prohibiting further infringement and, specifically, enjoining further use of methods and systems that come within the scope of the '207, '359, '299, and '970 patents.

# **REQUEST FOR RELIEF**

WHEREFORE, Plaintiff respectfully requests this Court to enter judgment against GLOBAL and its subsidiaries, affiliates, agents, servants, employees and all persons in active concert or participation with GLOBAL, granting the following relief:

- A. An award of damages against GLOBAL adequate to compensate Plaintiff for the infringement that has occurred with respect to GLOBAL, together with prejudgment interest from the date that GLOBAL'S infringement of the patents at issue began;
  - B. Increased damages as permitted pursuant to 35 U.S.C. § 284;
- C. A finding that this case is exceptional and award to Plaintiff its attorney's fees and costs as provided by 35 U.S.C. § 285;
  - D. All other relief as the Court or a jury may deem proper and just in this instance.

# COUNT II INDIRECT PATENT INFRINGEMENT

- 16. Plaintiff hereby incorporates Paragraphs 1 through 11 set forth above as if fully set forth herein.
- 17. Pursuant to 35 U.S.C. §§ 271(b) and (c), GLOBAL has indirectly infringed claims of the '207, '359, '299, and '970 patents through, among other activities, the commercial manufacture, sale, offer for sale and/or use of its "FREIGHT RECEIVING TRACKING" & "SMALL PACKAGE RECEIVING" ("Defendant's Systems") functions, applications, solutions, devices, programs, products, services, methods and/or systems which utilize tracking and messaging technologies that are protected within the '207, '359, '299, and '970 patents, as GLOBAL actively and intentionally induced infringement with knowledge that the induced acts constituted infringement, or acted with willful blindness; and/or contributed to infringement by one or more third parties as GLOBAL had knowledge, rather than intent, that its activity caused such infringement.
- 18. At a minimum, the Defendant's Systems in question infringe claims 1 and 8 of the '970 patent, in as much as it allows a user to track the movement of a vehicle that allows Defendants customers real-time access to their shipments (*The system has real-time access to data, maintaining instant accuracy of shipment information.*" www.applications.ges.com), and communicates a notification to a user of the vehicle's status through automated email updates (With the ability to set up automated alerts and track shipments on line...tracking has never been more convenient for show organizers and exhibitors." www.applications.ges.com).
- 19. GLOBAL'S contributory infringement and/or inducement to infringe has injured and will continue to injure Plaintiff unless and until a monetary judgment is entered in favor of

Plaintiff and/or the Court enters an injunction prohibiting further infringement and, specifically,

enjoining further use of methods and systems that come within the scope of the '970 patents.

REQUEST FOR RELIEF

WHEREFORE, Plaintiff respectfully requests this Court to enter judgment against

GLOBAL and its subsidiaries, affiliates, agents, servants, employees and all persons in active

concert or participation with GLOBAL, granting the following relief:

A. An award of damages against GLOBAL adequate to compensate Plaintiff for the

infringement that has occurred with respect to GLOBAL, together with prejudgment interest

from the date that GLOBAL'S infringement of the patents at issue began;

B. Increased damages as permitted pursuant to 35 U.S.C. § 284;

C. A finding that this case is exceptional and award to Plaintiff its attorney's fees and

costs as provided by 35 U.S.C. § 285;

D. All other relief as the Court or a jury may deem proper and just in this instance.

JURY DEMAND

Pursuant to Rule 38 of the Federal Rules of Civil Procedure, Plaintiff hereby demands a

trial by jury on all issues so triable.
