OTSUKA'S NOTICE OF APPEAL

Notice is hereby given that Otsuka Pharmaceutical Co., Ltd. ("Otsuka") appeals to the United States Court of Appeals for the Federal Circuit from the Order Entering Judgment of Noninfringement concerning U.S. Patent No. 8,759,350 ("the '350 patent") (D.I. 167) and accompanying Memorandum Opinion (D.I. 166), issued by the United States District Court for the District of New Jersey (Camden) on March 30, 2016. The Order was based on the District Court's construction of the claim terms "a/the pharmaceutical composition" and "in combination with," as they appear in the claims of the '350 patent. (*See, e.g.*, D.I. 166 at 2.) Otsuka further appeals all findings of fact and conclusions of law, opinions, orders, and rulings insofar as they

relate to those claim terms or to any other issue addressed in the Order granting Otsuka's Motion for Summary Judgment, including, inter alia, the District Court's Markman Order (D.I. 133) and accompanying Opinion (D.I. 132) and its Order denying Otsuka's Motion for Temporary Restraining Order (D.I. 77) and accompanying Opinion (D.I. 75, 76).
