COMPLAINT FOR PATENT INFRINGEMENT

Plaintiff complains and alleges:

- Plaintiff, Pants Un-Heeled, L. L. C., is a Florida Limited Liability
 Corporation, and its principal office and place of business is at 6430 N.
 W. 98TH Lane, Parkland, Florida 33076.
- Defendant, Daryn Pinelli upon information and belief is an individual, residing at 13575 Chase Road, Jackson California 95642 and is doing business as Out Ease Struts.
- 3. This action arises under the patent laws of the United States, more particularly 35 U.S.C. 271, 281, 28 U.S.C. 1391 and 1400.
- 4. On February 12, 2008, U.S. Letters Patent No. 7,328,460, was duly and legally issued to Cheryl Mancini, Parkland, Florida, for an invention of a "Pant Leg Lower End Reinforcing Structure and Pant Leg System" and said Mancini became the owner of said Letters Patent.

- 5. On April 8, 2009, said Cheryl Mancini, assigned absolutely said Letters

 Patent No. 5,821,858 (together with all emoluments, advantages,

 profits and benefits accruing or belonging thereto) to Plaintiff Pants

 Un-Heeled, L. L. C., a Florida Limited Liability Corporation.
- 6. Defendant has infringed and still is infringing the Letters Patent by making, selling and using the pant leg apparatus embodying the said invention throughout the United States including the Southern District of Florida, and will continue to do so unless enjoined by this court.
- 7. Plaintiff has complied with the statutory requirement of placing a notice of the Letters Patent on all pant leg apparatus it manufacturers and sells and has given the defendant written notice of the infringement.

THEREFORE, plaintiff demands:

- (a) For a preliminary and final injunction prohibiting further use by Defendant of the device covered by Plaintiff's patent.
- (b) An accounting for profits and damages, in the amount of not less than \$2,000,000, and for such further amount, as shall be established by the evidence.
- (c) An award of damages to Plaintiff plus interest thereon, and an increase of said damages to a sum three times the amount found as actual damages.
- (d) For an assessment of costs against Defendant, together with a reasonable attorneys fee to be allowed to Plaintiff by the Court.

(e) For such other and further relief as the court shall deem just and proper.
