This Notice is timely pursuant to the Court’s April 27, 2016 Minute Order [Dkt. No. 154], granting SHFL’s Motion to Extend Time and extending the time to file a notice of appeal to begin running from entry of an order disposing of Defendant’s pending Motion for Attorney Fees:

[P]ursuant to Rule 58(e) of the Federal Rules of Civil Procedure and Rule 4(a)(4)(A)(iii) of the Federal Rules of Appellate Procedure, Plaintiff SHFL Entertainment, Inc.’s [Dkt. No. 148] Motion to Extend Time is GRANTED. Accordingly, the time to file a notice of appeal shall run from the entry of the order disposing of Defendant DigiDeal Corporation’s [Dkt. No. 147] Motion for Attorney Fees pursuant to Rule (4)(a)(1) of the Federal Rules of Appellate Procedure.

(April 27, 2016 Minute Order [Dkt. No. 154].) On June 29, 2016 the Report and Recommendation & Order [Dkt. No. 163 (Amended in Dkt. No. 165)] of Magistrate Judge Ferenbach was issued, recommending that DigiDeal’s motion for attorneys’ fees [Dkt. No. 147] be denied. No objections to the Report and Recommendation were filed by either party.

On September 19, 2016 the District Court [Dkt. No. 168] accepted and adopted in full the Amended Report and Recommendation and denied DigiDeal’s Motion for Attorney Fees [Dkt. No. 147]. Accordingly, the time to file a notice of appeal began to run on September 19, 2016.
