COMPLAINT FOR PATENT INFRINGEMENT

1. This is an action for patent infringement in which Orthosie Systems, LLC (“OS” or “Plaintiff”), makes the following allegations against Omnitrac Holdings, LLC and Omnitrac, LLC (collectively, “Omnitrac” or “Defendants”).

PARTIES

2. Plaintiff Orthosie Systems, LLC (“Plaintiff” or “OS”) is a Texas limited liability company with a principal place of business at 1333 W. McDermott Drive, Suite 200, Allen, Texas 75013. Plaintiff’s president is Daniel F. Perez.

3. On information and belief, Omnitrac, LLC is an Delaware company. Omnitrac, LLC maintains a website stating that its headquarters are at 717 N. Harwood Street, Suite 1300, Dallas, TX 75201. Omnitrac, LLC’s franchise filing with the Texas Secretary of State lists the company’s mailing address as 10182 Telesis Ct., Suite 100, San Diego, CA 92121. Omnitrac, LLC’s Registered Agent for service of process in Texas is Corporation Service Company, 211 E. 7th St., Suite 620, Austin, TX 78701.

4. On information and belief, Omnitrac Holdings, LLC is an Delaware company. Omnitrac Holdings, franchise filing with the Texas Secretary of State lists the company’s mailing address as 717 N. Harwood Street, Suite 1300, Dallas, TX 75201 – which is identical to Omnitrac, LLC’s headquarters address. Omnitrac Holdings, LLC does not appear to have a Registered Agent for service of process in Texas.

JURISDICTION AND VENUE

5. This action arises under the patent laws of the United States, Title 35 of the United States Code. This Court has subject matter jurisdiction pursuant to 28 U.S.C. §§ 1331 and 1338(a).

6. Venue is proper in this district under 28 U.S.C. §§ 1391(c) and 1400(b). On information and belief, Defendants have transacted business in this district, and have committed acts of patent infringement in this district.

7. On information and belief, Defendants are subject to this Court's specific and general personal jurisdiction pursuant to due process and/or the Texas Long Arm Statute, due at least to their substantial business in this forum, including: (i) at least a portion of the infringements alleged herein; and (ii) regularly doing or soliciting business, engaging in other persistent courses of conduct, and/or deriving substantial revenue from goods and services provided to individuals in Texas and in this Judicial District.

8. On information and belief, Defendant has transacted or conducted business with companies that operate Omnitrac systems in cities across Texas, and within the Eastern District of Texas.

COUNT I
INFRINGEMENT OF U.S. PATENT NO. 7,430,471

9. Plaintiff is the owner by assignment of the valid and enforceable United States Patent No. 7,430,471 ("the '471 Patent") entitled "Method and System for Monitoring a Vehicle" – including all rights to recover for past and future acts of infringement. The '471 Patent issued on September 30, 2008. A true and correct copy of the '471 Patent is attached as Exhibit A.

10. Upon information and belief, the Defendant – either directly, or through intermediaries including distributors, wholesalers, partners, contractors, retailers, employees, divisions, branches, subsidiaries, parents, or suppliers – made, had made, used, operated, imported, provided, supplied, distributed, offered for sale, sold, and/or rented tracking devices including, but not limited to Omnitrac's: "OTIS 1"; "OTIS 2"; "MCP 50"; "MCP110"; "MCP 200"; "MCP100" and "TT210" devices (collectively, "Omnitrac Tracking Devices").

11. Upon information and belief, the Defendant – either directly, or through intermediaries including distributors, wholesalers, partners, contractors, retailers, employees, divisions, branches, subsidiaries, parents, or suppliers – made, had made, used, operated, imported, provided, supplied, distributed, sold, and/or offered for sale assert tracking software systems, software as a service (“SaaS”) systems; and/or applications that include, but are not limited to Omnitracs’: “XRS”; “Enterprise Services”; “Roadnet Transportation Suite”; “Roadnet Anywhere”; and “Analytics” software platforms (collectively, “Omnitracs Software Platforms”).

12. Upon information and belief, the Defendant – either directly, or through intermediaries including distributors, wholesalers, partners, contractors, retailers, employees, divisions, branches, subsidiaries, parents, or suppliers – made, had made, used, operated, imported, provided, supplied, distributed, offered for sale, and/or sold one or more Omnitracs Software Platforms in a as software as a service (“SaaS”) format.

13. Upon information and belief, Omnitracs Tracking Devices are built, designed, manufactured, marketed, rented, and/or sold to operate in conjunction with Omnitracs Software Platforms.

14. Upon information and belief, Omnitracs Tracking Devices operate in conjunction with Omnitracs Software Platforms (collectively, “Omnitracs Tracking System”) to provide a user with a central monitoring and/or control interface on a desktop or mobile computing device.

15. Upon information and belief, Omnitracs Tracking Systems operate such that a user’s central monitoring and/or control interface receives and/or sends data transmissions or signals from and/or to a Omnitracs Tracking Device installed in a vehicle or other mobile asset.

16. Upon information and belief, Omnitracs Tracking Systems operate such that a user’s central monitoring and/or control interface receives and/or sends data transmissions or signals from and/or to a Omnitracs Tracking Device indicating movement or activation of a vehicle or other mobile asset.

17. Upon information and belief, Omnitracs Tracking Systems operate such that a user’s central monitoring and/or control interface receives and/or sends data transmissions or signals from and/or to a Omnitracs Tracking Device indicating identification of the driver or other operator of a vehicle or other mobile asset.

18. Upon information and belief, Omnitracs Tracking Systems operate such that a user's central monitoring and/or control interface receives and/or sends data transmissions or signals from and/or to a Omnitracs Tracking Device indicating time(s) of activation or operation of a vehicle or other mobile asset.

19. Upon information and belief, Omnitracs Tracking Systems operate such that a user's central monitoring and/or control interface receives and/or sends data transmissions or signals from and/or to a Omnitracs Tracking Device indicating location of a vehicle or other mobile asset.

20. Upon information and belief, Omnitracs Tracking Systems operate such that a user's central monitoring and/or control interface receives and/or sends data transmissions or signals from and/or to a Omnitracs Tracking Device indicating location of a landmark or other geographic reference point.

21. Upon information and belief, Omnitracs Tracking Systems operate such that a user's central monitoring and/or control interface receives and/or sends data transmissions or signals from and/or to a Omnitracs Tracking Device indicating location of a vehicle or other mobile asset in relation to a landmark or other geographic reference point.

22. Upon information and belief, Omnitracs Tracking Systems operate such that a user's central monitoring and/or control interface receives and/or sends data transmissions or signals from and/or to a Omnitracs Tracking Device utilizing Global Positioning System (GPS) receivers and/or transmitters.

23. Upon information and belief, Omnitracs Tracking Systems operate such that a user's central monitoring and/or control interface receives and/or sends data transmissions or signals from and/or to a Omnitracs Tracking Device utilizing radio signal receivers and/or transmitters, including but not limited to cellular communications networks.

24. Upon information and belief, Omnitracs Tracking Systems operate such that a user's central monitoring and/or control interface receives and/or sends data transmissions or signals from and/or to a Omnitracs Tracking Device including vehicle and/or engine operation or diagnostic data.

25. Upon information and belief, users, customers, subscribers, and/or operators of Omnitracs' SaaS Systems utilize those systems under the direction and control of Omnitracs.

26. Upon information and belief, the Defendant's Omnitracs Tracking Systems, when used and/or operated in their intended manner or as designed, infringe one or more claims of the '471 Patent, and Defendant is therefore liable for infringement of the '471 Patent .

DEMAND FOR JURY TRIAL

Plaintiff, under Rule 38 of the Federal Rules of Civil Procedure, requests a trial by jury of any issues so triable by right.

PRAYER FOR RELIEF

WHEREFORE, Plaintiff respectfully requests that this Court enter:

- a. A judgment in favor of Plaintiff that Defendant has directly infringed the '471 Patent;
- b. A permanent injunction enjoining Defendant and its officers, directors, agents, servants, affiliates, employees, divisions, branches, subsidiaries, parents, and all others acting in active concert therewith from infringement of the '471 Patent;
- c. A judgment and order requiring Defendant to pay Plaintiff its damages, costs, expenses, and pre-judgment and post-judgment interest for Defendant's infringement of the '471 Patent as provided under 35 U.S.C. § 284;
- d. An award to Plaintiff for enhanced damages resulting from the knowing and deliberate nature of Defendant's prohibited conduct with notice being made at least as early as the service date of this complaint, as provided under 35 U.S.C. § 284;
- e. A judgment and order finding that this is an exceptional case within the meaning of 35 U.S.C. § 285 and awarding to Plaintiff its reasonable attorneys' fees; and
- f. Any and all other relief to which Plaintiff may show itself to be entitled.
