PLEASE TAKE NOTICE THAT Defendants Sealant Systems International, Inc., and ITW Global Tire Repair (collectively, “SSI”) hereby appeal to the United States Court of Appeals for the Federal Circuit from the Judgment entered on the Jury’s verdict in this case, dated April 6, 2017 (Docket No. 514) and all adverse orders, rulings, findings, instructions, opinions and/or conclusions that gave rise to that Judgment, including but not limited to the portion of the District Court’s Order Denying Motions for Summary Judgment of Infringement denying SSI’s Renewed Motion for Summary Judgment of Non-Infringement or, Alternatively, Motion for Summary Judgment (Docket No. 396); the District Court’s Order Denying Motion for Summary Judgment on Invalidity (Docket No. 397); the Memorandum Opinion and Order, entered on April 6, 2017 (Docket No. 513); the portions of the District Court’s Order Re Post-Trial Motions, entered on August 1, 2017 (Docket No. 561) (i) denying SSI’s Renewed Motion for Judgment as a Matter of Law (Docket No. 530); (ii) denying SSI’s Motion for New Trial and/or Remittitur (Docket No. 531); (iii) granting Plaintiffs TEK Global, S.r.l. and TEK Corporation’s (collectively, “TEK”) Motion for Permanent Injunction (Docket No. 534); and (iv) granting-in-part TEK’s Motion for Supplemental Pre-Verdict Damages, an Accounting of Post-Verdict Infringing Sales; and Pre- and Post-Judgment Interest (Docket No. 535); and the Permanent Injunction, entered on August 11, 2017 (Docket No. 564).
