COMPLAINT

For its Complaint, Plaintiff Lexos Media IP, LLC ("Lexos Media"), by and through the undersigned counsel, alleges as follows:

THE PARTIES

- 1. Lexos Media is a Delaware limited liability company with a place of business located at 555 Republic Drive, 2nd Floor, Plano, Texas 75074.
- 2. Defendant Williams-Sonoma, Inc. is a Delaware company with, upon information and belief, a place of business located at 178 Christiana Mall, Newark, Delaware 19702.
- 3. On June 27, 2017, Lexos Media's licensing agent sent via priority mail a letter to Defendant's General Counsel informing Defendant of the patents-in-suit, and Defendant did not respond to Lexos Media's licensing agent.

JURISDICTION AND VENUE

- 4. This action arises under the Patent Act, 35 U.S.C. § 1 et seq.
- 5. Subject matter jurisdiction is proper in this Court under 28 U.S.C. §§ 1331 and 1338.
- 6. Upon information and belief, Defendant conducts substantial business in this forum, directly or through intermediaries, including: (i) at least a portion of the infringements

alleged herein; and (ii) regularly doing or soliciting business, engaging in other persistent courses of conduct and/or deriving substantial revenue from goods and services provided to individuals in this district.

7. Venue is proper in this district pursuant to 28 U.S.C. § 1400(b).


THE PATENTS-IN-SUIT

- 8. On November 30, 1999, U.S. Patent No. 5,995,102 (the "'102 patent"), entitled "Server System and Method for Modifying a Cursor Image," was duly and lawfully issued by the U.S. Patent and Trademark Office. A true and correct copy of the '102 patent is attached hereto as Exhibit A.
- 9. On September 12, 2000, U.S. Patent No. 6,118,449 (the "'449 patent"), entitled "Server System and Method for Modifying a Cursor Image," was duly and lawfully issued by the U.S. Patent and Trademark Office. A true and correct copy of the '449 patent is attached hereto as Exhibit B.
- 10. Lexos Media is the assignee and owner of the right, title and interest in and to the '102 and '449 patents, including the right to assert all causes of action arising under said patents and the right to any remedies for infringement of them.

COUNT I – INFRINGEMENT OF U.S. PATENT NO. 5,995,102

- 11. Lexos Media repeats and realleges the allegations of paragraphs 1 through 10 as if fully set forth herein.
- 12. Without license or authorization and in violation of 35 U.S.C. § 271(a), Defendant is liable for infringement of the '102 patent through the making, using, importing, offering for sale, and/or selling a server system for modifying a cursor image to a specific image having a desired shape and appearance displayed on a display of a remote user's terminal.

13. More specifically and upon information and belief, Defendant's server system includes one or more web servers which are accessible via the Internet. *See* https://www.williams-sonoma.com/products/philips-avance-airfryer/ ("Exemplary Page"). The "cursor image" is a user's cursor on the webpage.



Exemplary Page. The "specific image" is the image that the cursor turns into when certain conditions are met, and the cursor image data includes graphical data, such as JPEG, GIF, PNG, BMP, ICO, or CUR data, for example, associated with the specific image. An example of cursor image data is the JPEG data that makes up the modified cursor image.



JURY DEMAND

Lexos Media hereby demands a trial by jury on all issues so triable.

PRAYER FOR RELIEF

WHEREFORE, Lexos Media requests that this Court enter judgment against Defendant as follows:

A. An adjudication that Defendant has infringed the '102 and '449 patents;

B. An award of damages to be paid by Defendant adequate to Lexos Media for Defendant's past infringement of the '102 and '449 patents, including interest, costs, expenses and an accounting of all infringing acts including, but not limited to, those acts not presented at trial;

C. A declaration that this case is exceptional under 35 U.S.C. § 285, and an award of Lexos Media's reasonable attorneys' fees;

D. An award to Lexos Media of such further relief at law or in equity as the Court deems just and proper.
