**NOTICE OF APPEAL**

Notice is hereby given that MiiCs & Partners, America, Inc. and Gold Charm Limited (collectively, “MiiCs”), plaintiffs in the above captioned case, hereby appeal to the United States Court of Appeals for the Federal Circuit from the final judgment entered in this action in the United States District Court for the District of Delaware on October 24, 2017 [D.I. 578], and from any and all judgments, orders, opinions, and findings (interlocutory or otherwise), pertinent or ancillary to the foregoing, including but not limited to:

(1) Memorandum Opinion [D.I. 576] and Memorandum Opinion [D.I. 577], dated October 24, 2017 in C.A. No. 14-803-RGA, granting summary judgment of non-infringement in favor of Defendants Toshiba Corporation and Toshiba America Information System, Inc. and Intervenor Samsung Display Co., Ltd.;

(2) Claim Construction Memorandum Opinion [D.I. 167] dated August 31, 2016 and Claim Construction Order [D.I. 171] dated September 6, 2016; and

(3) Memorandum Opinion [D.I. 534] and Order [D.I. 535] dated August 11, 2017 granting partial summary judgment of non-infringement in favor of Defendants Toshiba Corporation and Toshiba America Information System, Inc. and Intervenor Samsung Display Co., Ltd.
